

USA HOCKEY CLUB OF MICHIGAN
WELCOMES YOU TO THE 2009 – 2010 SEASON

While we realize that it seems that the hockey season has just begun, it is already time to register for next fall's hockey season. The information given below will assist you in properly registering your child for next year.

To register your skater for the Fall/Winter 2009 – 2010 season, you must complete the attached forms and provide us with a check in the amount of \$175.00 per skater. To submit your registration, you can come to the USA Hockey Club office at Detroit Skating Club on Saturday, March 21 between the hours of 10:00 am and 2:00 pm OR mail the signed forms and check to USA HOCKEY CLUB, P.O. Box 312, Bloomfield Hills, MI 48303. The forms MUST BE POSTMARKED by March 21 or your application will be placed in a waiting list file. Every level had a waiting list for the 2008/2009 season so do not delay. Please provide a separate check and registration form for each skater you are registering. ****PLEASE NOTE: THIS REGISTRATION FEE IS NON-REFUNDABLE under any circumstances, unless no team position is available for your skater.**

The registration fee includes the purchase of two new jerseys for your skater. These jerseys will become the property of the skater at the conclusion of the season. As in previous seasons, socks will be provided and, in addition, pucks, trophies, yearbooks, coaches' clinics and club clerical and support services are provided for each team from this fee.

Please note that registration does not necessarily guarantee placement on a team. Ice availability, number of registrants per age level, district eligibility, and other MAHA requirements influence the number of teams we can support. Registrations received after March 21 will be dated and prioritized and accepted according to space availability. (NOTE: Only those players that cannot play due to Club space or MAHA rule limitations

To register your child with the USA Hockey Club of Michigan for the upcoming 2009-2010 season, please complete the information listed below and then do one of the following: mail form and \$175.00 check (**NO CASH PLEASE**) to USA HOCKEY CLUB OF MICHIGAN at P.O. Box 312, Bloomfield Hills, MI 48303 postmarked by March 21, 2009 or bring them to registration on Saturday, March 21 between 10:00 am – 2:00 pm at the Detroit Skating Club in the **USA Hockey Club office in Rink B**. Please be sure to complete all of the requested information on both sides of the form completely. The \$175.00 registration fee (**CHECK ONLY**) should be made payable to the USA Hockey Club of Michigan. Remember that this fee includes but is not limited to your child's two new jerseys and socks, trophy and yearbook as well as their draft skate fee for the upcoming season.

I will be an **active participant** in scheduled games, practices and team function to the best of my ability. I understand that in accordance with USA HOCKEY CLUB rules, all dues and/or fees must be paid by the due date. Non-payment of any dues and/or fees will result in suspension from team participation and termination of all membership privileges. **All dues and/or fees will be non-refundable.**

PARENT OR GUARDIAN AGREEMENT AND WAIVER

I, _____, the parent/guardian of the above applicant, give USA HOCKEY CLUB OF MICHIGAN, my consent of the player's agreement outlined above. As an active member of USA HOCKEY CLUB OF MICHIGAN, I assume all risks and hazards associated with the sport of ice hockey incidental or otherwise. This includes travel to and from scheduled team activities in addition to those activities directly associated with team participation. Therefore, I waive, release, absolve, indemnify and agree to hold harmless the USA HOCKEY CLUB OF MICHIGAN the USA HOCKEY CLUB OF MICHIGAN, its officers, directors, sponsors, supervisors, coaches, assistant coaches, managers, referees, and other participants and persons associated with USA HOCKEY CLUB OF MICHIGAN for any and all claims arising out of injury to my child.

In addition, I give USA HOCKEY CLUB OF MICHIGAN and its representatives the right to arrange, obtain and approve any medical attention deemed necessary for the health and well-being of the above applicant for injuries sustained during any USA HOCKEY CLUB OF MICHIGAN event or activity. I understand and accept that I am responsible for any medical expenses not covered by my insurance provider.

As indicated by their signatures, this does constitute an agreement to play for the USA HOCKEY CLUB OF MICHIGAN FOR THE 2009 – 2010 fall/winter season. A player cannot play for another team, association, or independent for said season unless released by the USA HOCKEY CLUB OF MICHIGAN. This is so stated in the by-laws of the Little Caesar's Amateur Hockey League (LCAHL), within which we play and is recognized by the Michigan Amateur Hockey Association (MAHA) as a binding contract.

I understand that acceptance of this registration form DOES NOT necessarily guarantee my child a place on a team. Players and family members with seniority with the club will be given first priority. I further understand that the registration fee is NON-REFUNDABLE unless no team position is available for said skater. I further agree to return all equipment issued to me and to replace any said equipment that has been damaged due to negligence or abuse while in my care and/or custody.

WE HAVE READ THE FOREGOING, UNDERSTAND IT CONTENTS, DESIRE TO HAVE OUR CHILD PLAY FOR THE CLUB AND AGREE TO ABIDE BY THE BY-LAWS AND RULES OF THE USA HOCKEY CLUB OF MICHIGAN, LCAHL, MAHA, AND USA HOCKEY.
